



IHPA Participates in Cultural Advocacy Day

February 11 was Cultural Advocacy Day. The sessions began with addresses from Senator Bill Dotzier of Waterloo, Representative Clarence Hoffman of Charter Oak, and First Lady Christie Vilsack. The participants then marched to the Capitol where many visited with their legislators about support of Iowa's Cultural programs.

IHPA, along with several other organizations, had an information table set up at the Capitol. The display included photo collections of properties on Iowa's Most Endangered Properties and a group of Iowa barns.

Nominations Sought for lowa's Most Endangered Properties listing

Nominations are being sought for IHPA's annual list of Iowa's most endangered properties.

The list will be announced at the IHPA's annual conference which will be held in Monticello in July.

The IHPA has been sponsoring the endangered list since 1996. Seventy four properties have been listed since the beginning of the program.

Deadline for receiving nominations June 1, 2004. Any individual or organization may submit nominations.

A panel of judges, familiar with preservation projects, will select the properties they believe to be most significant. Nominations are judged on historical significance, nature of threat, variety of building type and geographic distribution.

President's Message

Save it now!

From my limited experience in preservation, I've learned a couple of things:

- 1) Preservation is local and 2) It's better to save it sooner than when it's too late. Here's why.
- 1) No one cares about a building, parcel of land or important piece of history more than the people close to it. On a state and national level, we can try to increase preservation awareness and influence policy, but when it comes to a specific building, for example, it takes local energy to protect and restore it. This includes everything from recognizing a valuable historic asset and working to get it recognized by a local historic commission or the National Register of Historic Places, to purchasing an asset and working to preserve it, to standing in front of the bulldozer if it comes to that.
- 2) It's usually too late to do much when you learn the wrecking ball or bulldozer has been asked to destroy a building. That's often the stage when IHPA gets a frantic phone call. We don't mind getting those calls at all, but if people would act sooner, it might not get to that stage. IHPA can best help at an earlier stage, including suggesting grants, trying to mediate a purchase or involving the National Trust. I was happy to get a proactive call recently regarding the Maplehurst House in Keota. A concerned person who had grown up near there has been working with the current owner who will eventually sell the property and acreage it is on. They want to find a way now to ensure the mansion is preserved as part of the sale rather than waiting until a future owner might decide it is not an asset on the land. I applaud the effort and we will do what we can. Toward that end, if anyone has any ideas on that, please email me at tsmull@inanews.com or call 515-280-7234.

So please act now to recognize and preserve those things important to you and you'll have a better chance at success. Thank you for your membership in IHPA and for your support!

MUSCATINE COUNTY

WEST LIBERTY COMMERCIAL HISTORIC DISTRICT, BOUNDED BY 4TH STREET, RAILROAD TRACKS, CLAY, AND SPENCER STREETS, WEST LIBERTY



The Historic District's significance lies in its representation of the central business district from the late 1860s to the present and its reflection of the many varied enterprises that evolved in the late 19th to early 20th centuries within this community. The architectural significance of the district lies in the retention and integrity of many of the historic buildings constructed between 1867 and 1948.

POLK COUNTY

FLEMING BUILDING, 218 6TH AVE, DES MOINES



The Fleming Building is locally significant under Criterion C, as a commercial office building of distinctive architectural and structural character designed by the nationally renowned architectural firm of D. H. Burnham and Company.

HOHBERGER BUILDING, 502-506 E. LOCUST STREET, DES **MOINES**



The Hohberger Building is significant as a good example of a cast-iron building in Des Moines.

POTTAWATTAMIE COUNTY

100 BLOCK OF WEST BROADWAY, COUNCIL **BLUFFS**



This historic commercial district is locally significant under criterion C. It was constructed between the mid-1850s to late 1920s. This block represents the only surviving section along the entirety of Broadway to retain so many of its historic buildings .The District is locally significant under Criterion A.

TAYLOR COUNTY

BEDFORD COMMERCIAL HIS-TORIC DISTRICT, 200-500 BLOCKS MAIN STREET, 500-600 BLOCKS COURT, 600 BLOCK CENTRAL, BEDFORD



The Bedford Commercial District is historically signifi- nificant as an outstanding excant in its representation of the central business district from the 1850s to the present and its reflection of the many varied enterprises that evolved in the late 19th and early 20th centuries within this community. The architectural significance lies in the retention and integrity of many of the historic buildings constructed between the 1850s and 1952.

1400 - 1700 BLOCKS OF DOUG-LAS ST. GRANDVIEW BLVD. AND SUMMIT ST., SIOUX CITY

The Rose Hill District is locally significant under Criterion A for its association with an important era of population growth and intense residential development in Sioux City at the end of the 19th century and the beginning of the 20th century. The architecture of the district represents a range of building type, style and form. Eight architects or firms have been identified with buildings in the district.

The Goodin Building is locally significant under Criterion C. Constructed in 1875, it has the influence of Romanesque Revival. It is associated with the community's core of old surviving businesses.
